Controlled Placement Agreement Extension and Increase

PepinNini Minerals Limited (PepinNini, the Company) is pleased to announce it has agreed with Acuity Capital to extend the expiry date of the current Controlled Placement Agreement (“CPA”).

As previously announced, the CPA provides PepinNini with up to \$5m of standby equity capital (see announcements 1 February 2018, 4 June 2018 and 30 January 2020).

Following the extension, the new expiry date of the CPA is now 31 January 2023.

As consideration for the above and following the recent share consolidation completed in September 2020, the Company has agreed to adjust the security held by Acuity Capital under the CPA to a total of 1 million PNN shares. This will be achieved through the Company issuing an additional of 811,778 PNN shares out of its LR7.1 capacity (“Collateral Shares”). Though the Company may, at any time, terminate the CPA as well as buy back and cancel the Collateral Shares for nil consideration (subject to shareholder approval). There were no fees or costs associated with the extension.

An Appendix 2A is attached to request quotation for the collateral shares and shares pursuant to the Placement announced 22 December 2020.
