## Share Placement Update

PepinNini Lithium Limited (PepinNini, the Company) wishes to announce the placement of an additional 40 million ordinary fully paid shares in the Company at \$0.001 (0.1 of a cent) each, this increases the share placement announced 21 August to total placement of 205 million ordinary fully paid shares raising a total of \$205,000 before costs.

The placement of 205 million shares has been made to investors to whom one or more of the exceptions in section 708 of the *Corporations Act* applies. Proceeds from the capital raised will be used to progress the Company's Musgrave Project in South Australia and for working capital.

In accordance with Listing Rule 3.10.3, the Company provides the following details of the placement shares:

<b>Shareholder Approval:</b>	The Company will not seek shareholder approval prior to the issue of the 165 million placement shares, as the placement share issue is being made under the Company's 15% placement capacity under LR7.1.
<b>Issue to Class:</b>	The issue is not being made to a class of security holders. The shares will be quoted as ordinary securities on the ASX.  As the issue will be made to investors to whom one or more of the exceptions in section 708 of the <i>Corporations Act</i> applies, it will not require disclosure under the <i>Corporations Act</i> .

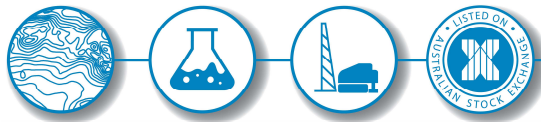
